



Flexible Testing Tool Software Single Seat License Agreement

IMPORTANT-READ CAREFULLY: This license agreement is a legal agreement between you and Forward Thinking, Inc., regarding computer software and associated media and printed materials, and may include “online” or electronic documentation (collectively “Software”).

By using this Software, you agree to be bound by the terms of this license agreement.

The copyrights laws and international copyright treaties, as well as other intellectual property laws and treaties, protect this Software.

1. License Grant. Subject to mutual acceptance of these terms, Forward Thinking grants to Licensee a non-exclusive, transferable license to use the Flexible Testing Tool Software, including Software documentation provided with such Software (hereafter “Licensed Software”), on a single central processing unit (hereinafter “Seat”). The Licensed Software may not be copied except as necessary to use the Licensed Software on the single seat identified above. Additional copies of the Licensed Software may be licensed from Forward Thinking at the then current licensing fee.

2. Ownership. Forward Thinking and / or its licensors retain ownership of the Licensed Software including all patents, copyrights, and other intellectual property rights.

2.1 Licensee may transfer its rights under this license as long as the receiving party agrees to be bound by the terms of this agreement, and the original Licensee no longer uses the Licensed Software (including all component parts, the media, and printed materials and this license agreement). The receiving party’s right to use the Licensed Software shall be limited to the single “Seat”.

2.2 Licensee agrees not to, in whole or in part, reverse engineer, decompile, disassemble, modify, rent, lease, or create derivative works of the Licensed Software for any purpose or in any manner.

2.3 Licensee agrees that (1) no license, right or interest in any trademark, trade name, or service mark of Forward Thinking, its licensors or any third party is granted under this Agreement; (2) Licensee is not permitted and shall not remove or destroy any of the Licensed Software’s proprietary, trademark or copyright legends or markings and (3) all existing and future copyright, patent, trademark, or other intellectual property rights arising out of or related to the Licensed Software shall remain the sole property of Forward Thinking and / or its licensors.

3. Scope Of Use. This Licensed Software may only exist on single seat per license. A backup copy may be made. With reference to the copy Licensee makes of the Licensed Software, Licensee agrees to reproduce all copyright notices, and other restrictive legends, appearing thereon and to include the same on all copies it makes in whole or in part. Such copyright notices may appear in any of several forms, including machine-readable form and Licensee agrees to reproduce such notice in each form in which it appears, to the extent it is physically possible to do so.

4. Term and Termination. Licensee shall use the Licensed Software from the date received only for the purposes stated in paragraph 1 during a ninety-nine (99) year time period, unless terminated as provided herein.

4.1 Forward Thinking may terminate this Agreement immediately should Licensee materially breach any of the provisions of this Agreement or take any action in derogation of Forward Thinking’ rights to the Licensed Software licensed hereunder. In addition, Forward Thinking may terminate this Agreement immediately should the Licensed Software, or any portion thereof, become, or in Forward Thinking’ opinion be likely to become, the subject of a claim of infringement of a patent, trade secret, copyright, mask work right, or other proprietary right.

4.2 Upon expiration or termination of this Agreement, Licensee shall immediately discontinue all use of the Licensed Software and, unless otherwise instructed by Forward Thinking, within thirty (30) days after such expiration or termination Licensee shall destroy all such Licensed Software and certify to Forward Thinking in writing signed by an authorized representative of Licensee that all such Licensed Software has been destroyed.

4.3 The rights and obligations under this Agreement, which by their nature should survive termination, will remain in effect after expiration or termination hereof.

5. Maintenance and Support. Forward Thinking will not be responsible for maintenance or support of the Licensed Software under this Agreement. Licensee may purchase maintenance and support from Forward Thinking through a separate maintenance and support agreement.

6. Limited Warranty. Forward Thinking warrants that under normal use, the Licensed Software shall perform the functions specified in its documentation. If the Licensed Software does not conform to its documentation such that its functional performance is significantly affected and Forward Thinking is notified in writing within ninety (90) days from the date of purchase along with a copy of the receipt of purchase, Forward Thinking shall have the option of refunding the purchase price or replacing the Licensed Software as Licensee's exclusive remedy. THIS WARRANTY IS EXCLUSIVE AND IN LIEU OF ALL OTHER WARRANTIES WHETHER STATUTORY, EXPRESS, OR IMPLIED (INCLUDING ALL WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE).

7. Liability. IN NO EVENT SHALL EITHER PARTY BE LIABLE FOR ANY SPECIAL, INCIDENTAL, PUNITIVE, INDIRECT OR CONSEQUENTIAL DAMAGES, (INCLUDING LOSS OF ECONOMIC ADVANTAGE, BUSINESS, PROFITS, DATA OR INACCURACY OF DATA), IN CONNECTION WITH OR ARISING OUT OF THIS AGREEMENT OR FROM USE OF LICENSED SOFTWARE, WHETHER OR NOT THE OTHER PARTY HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES AND REGARDLESS OF THE FORM OF ACTION OR LEGAL THEORY (WHETHER IN CONTRACT OR IN TORT, INCLUDING STRICT TORT LIABILITY, OR BASED ON A WARRANTY) UNDER WHICH THE LIABILITY MAY BE ASSERTED.

8. Government Rights In Commercial Licensed Software. If acquired under FAR policy (52.227-19), the U.S. Government shall obtain Restricted Rights in this Licensed Software. If acquired under DFARS policy (227.7202), the U.S. Government is granted only the commercial rights given in this License.

9. Records; Audit Rights. At all times during the term of this Agreement and for two (2) years following the termination of this Agreement, Licensee will maintain at its principal place of business accurate records relating to its licensing obligations under this Agreement, including identification of the receiving party of any Licensed Software transferred and the quantity of Licensed Software transferred. No more than once per year, Forward Thinking may, upon thirty (30) days written notice to Licensee, examine Licensee records related to License Software in use. Such examination will be done, at Forward Thinking' expense, by Forward Thinking personnel or an independent certified public accounting firm, provided, however, that if any such audit uncovers usage totaling in excess of five percent (5%) of the license amount due, Licensee will immediately reimburse Forward Thinking reasonable costs of such audit and the amount of underpayment for the usage uncovered during the course of the audit.

10. Export Compliance. Licensee agrees that it will not in any form export, re-export, ship, or divert or cause to be diverted, directly or indirectly, the Licensed Software to any country for which the United States Government, any agency thereof, or any other sovereign Government, at the time of export or re-export, requires an export license or other governmental approval without first obtaining such license or approval.

11. Applicable Law. The laws of the State of Arizona, excluding its conflicts of law principles, shall govern this Agreement.

12. Severability. If any of the provisions, or portions thereof, of this Agreement are found to be invalid under any applicable statute or rule of law, then, that provision notwithstanding, this Agreement shall remain in full force and effect and such provision or portion thereof shall be deemed omitted.

13. Payment: The rights granted hereunder to Licensee are contingent upon payment to Forward Thinking in accordance with the terms provided in the applicable Purchase Order for the Licensed Software.

14. Entire Agreement. By using the Licensed Software, Licensee acknowledges that this agreement has been read and understood and agrees to be bound by its terms and conditions. Licensee further agrees that this Agreement sets forth the sole and entire understanding with respect to this Licensed Software License, and merges and supersedes all prior oral and written agreements, discussions, and understandings, express or implied, concerning all matters related thereto. This Agreement may not be modified, amended or cancelled, in whole or in part, except by written agreement signed by both parties.
